One contest will be held to determine the SD State representative for the NHSRA Queen Contest unless 3 or more entries in a region are received. If this happens, all contestant's will be made aware of any changes in the contest.

A digital image needs to be emailed to Lynn McKay by May 1st, no crown or banner, it must be a headshot and should be High School legal attire. Email it to mckay@gwtc.net, and leave a message at 605-685-8800 with your phone number so that it can be returned if she is not home.

The contest will be held during State high School Rodeo Finals, June 16-20, 2020, at the Stanley County Fairgrounds in Fort Pierre, SD. Times TBD.

Each Regional Rodeo (8 regions) will provide \$150 in sponsorship for the state contest.
