3. 5 TIMERS-2 FOR EACH ARENA AND ONE FOR CUTTING
4. TRACTOR AND DRIVER, WITH ASSOCIATED EQUIPMENT
5. 3 WORKERS TO SORT AND LOAD TIMED EVENT STOCK
6. ANNOUNCER IN THE CUTTING ARENA
7. SECRETARY/CAMERA PERSON IN CUTTING ARENA
8. FLAGGER IN CUTTING ARENA
9. GATE OPENERS IN EACH ARENA
10. 2 WORKERS IN THE TIMED EVENT STRIPPER PEN
11. 2 WORKERS IN THE GOAT ARENA
12. 1 GOAT HOLDER
13. 2 WORKERS TO UNTIE CALVES
14. 1 ARENA CLEANER/TIMED EVENT

### **AMBULANCE**

1. ONE ON SITE-ONE ON CALL

### **AWARDS-FURNISHED BY HOST**

1. 5 BUCKLES PER EVENT-14 EVENTS-2 ALLAROUND-2 RESERVE ALLAROUND-2 ROOKIES-TOTAL OF 74 BUCKLES (STATE)
2. BUCKLES BID BASE PRICE PRESENTED WITH CONTRACT-QUALITY IS A REQUIREMENT (STATE)

### **PROGRAMS (STATE)**

1. ANNUAL POINT SYSTEMS, PAST WINNERS, AWARD DEDICATIONS WILL BE INCLUDED
2. DAY SHEETS INSERTS
3. SHORT GO INSERTS
4. 32 PAGES REQUIRED FOR SDHSRA INFORMATION
5. ONE HALF OF NET GOES TO SDHSRA

### **STALLS (STATE)**

1. ADEQUATE STALLS ON GROUNDS
2. ADEQUATE WATERING FACILITIES FOR LIVESTOCK

### **STOCK CONTRACTOR MUST CONFORM TO NHSRA RULEBOOK (STATE)**

1. STOCK CONTRACTOR MUST CONFORM TO SDHSRA GROUND RULES AND THE NHSRA RULEBOOK
2. SEPARATE STOCK BIDS SHOULD BE PRESENTED TO THE HOST COMMITTEE AND SDHSRA BOARD OF DIRECTORS FOR ROUGH STOCK AND TIMED EVENT STOCK

3. HOST RESPONSIBLE FOR ALL ROUGH STOCK, TIMED EVENT STOCK, CUTTING CATTLE AND GOATS WITH FINAL APPROVAL OF STOCK CONTRACTORS BY DIRECTORS AT MID-WINTER DIRECTORS MEETING
4. LIVESTOCK INSPECTION COMMITTEE AND STOCK SELECTIONS COMMITTEE'S WILL BE APPOINTED BY THE SDHSRA BOARD OF DIRECTORS AT MID-WINTER MEETING
5. ADEQUATE WATER AND HOLDING FACILITIES FOR LIVESTOCK PROVIDED BY HOST

#### **MOTELS AND RESTAURANTS (WITHIN A 30 MILE RADIUS OF FINALS)**

1. AVAILABILITY OF MOTELS
2. AVAILABILITY OF RESTAURANTS
3. CAMPER FACILITIES
4. ONE COMPLIMENTARY ROOM FOR EACH SDHSRA DIRECTOR
5. TWO COMPLIMENTARY ROOMS FOR SECRETARIES/ OFFICE PERSONNEL. ONE FOR NATIONAL DIRECTOR

#### **BID CONSIDERATIONS**

1. STATE FINALS-\$5000 MINIMUM

#### **CONCESSIONS**

1. CONCESSION STAND FURNISHED AND ON GROUNDS
2. SERVE SPONSOR PRODUCTS
3. PRICES AND SERVICE MUST CONFORM TO FAMILY ORIENTATION

#### **DANCES**

1. HOST SHALL FURNISH MUSIC
2. CHAPERONS
3. SECURITY

#### **ARENA CONDITIONS**

1. RODEO OFFICE AND PHONE ON GROUNDS WITH INTERNET CONNECTION
2. THREE ARENAS-ARENA SOIL CONDITIONS-JUDGEMENT OF DIRECTORS
3. QUEEN FACILITIES-HOSTING THE QUEEN CONTEST
4. ADEQUATE LIGHTS AND ELECTRICITY
5. FURNISH A PA SYSTEM
6. ADEQUATE PANELS-TURN BACK FENCE AND CUTTING EVENTS

#### **COMMITTEE STRUCTURE SHALL CONSIST OF:**

1. THREE MEMBERS OF HOST COMMITTEE WHO SHALL SERVE AS MEMBERS OF SDHSRA BOARD OF DIRECTORS (WITH VOTING RIGHTS EXCEPT IN SITE SELECTION)
2. FOUR MEMBERS OF SDHSRA BOARD OF DIRECTORS WHO SHALL SERVE ON HOST COMMITTEE (ONE FROM EACH REGION)

3. OTHER MEMBERS OF HOST COMMUNITY AS NEEDED TO FULFILL COMMITTEE RESPONSIBILITY
4. SDHSRA SECRETARY

FAILURE TO MEET REQUIREMENTS DURING TWO YEAR CONTRACT WILL MAKE SAID CONTRACT NULL AND VOID FOR REMAINDER OF CONTRACT
